PRICING & TICKET AGREEMENT

1. All prices quoted are subject to availability, fluctuation and **supplier terms and conditions** which is subject to change without notice.
2. Prior to full and final payment being received, TP World Tours reserve the right to vary prices and rates in the event of changes in price rises made by wholesalers or third party suppliers. If the cost of any service increases due to price increases, tax changes or any other reason, you are required to pay the increase when notified by TP World Tours.
3. Rates quoted are appropriate to the particular product at the time of quoting and these rates may change prior to the parade date.
4. All performers must purchase the Parade Only Performer Package – no annual passes are accepted for entry due to backstage requirements.
5. All Directors and Backstage Chaperone must purchase entry pass ticket – no annual passes are accepted for entry due to backstage requirements.
6. Any siblings, parents, grandparents and friend who are attending Dreamworld to support and watch the group can be added to Additional Guest Ticket order based on Dreamworld 1 Day Pass Only & Lunch Voucher.
7. Any siblings, parents, grandparents and friend who are attending Dreamworld to support and watch the group and hold a Dreamworld Saver Annual Pass or Local Annual Pass can use these passes for entry to Dreamworld however entry will be based on own arrangements and Additional Guest Ticket inclusions will not be included.

MINIMUM GROUP NUMBER AGREEMENT

8. Minimum parade group number is based on 15 dancers. Should your total number of dancers fall below 15 dancers your parade application will be assessed at the time of booking.
9. The Dreamworld Parade requires a minimum of 100 dancers in order for the event to proceed. If total dancers falls under the minimum requirements and the parade is cancelled by TP World Tours / Dreamworld any funds paid will be refunded at that time.
10. One Director and one Studio Chaperone is permitted backstage per participating studio.
11. All dancers must be 7 years and up to participate in Dreamworlds Spring County Fair Parade.

COSTUME & FILMING EVALUATION

12. Photos of your parade costume (including Front & Back) and accessories are to be submitted to TPWT for approval by the below due date. Failure to provide photos of your costume & accessories by the specified due date will result in cancellation of your parade booking.
13. Parade costume submissions are required to include a photo of the Front & Back of the costume worn by a dancer. Photo should include dancer to be performance ready including hair wiglet, accessories (if applicable), tights & parade shoes.
14. Costume submission can be emailed to TPWT prior to the scheduled due date for approval as this will allow studios more time to finalise for dancers.
15. Please do not purchase/order costumes until official approval has been sent through from TPWT.
16. In the case of costume not meeting the required standards, studios will be advised by email along with an explanation. Studios will be required to provide an alternate costume for approval.
17. Studios are required to follow the costume guidelines provided by TPWT at the time of booking.
18. All studios are required to submit a video evaluation of the parade performance by the specified due date. The video evaluation will need to show all dancers performing the entire routine and in parade formation. Failure to provide video evaluation by the specified due date will result in cancellation of your parade booking.
19. Please ensure you are aware of the surface you are performing on as it is concrete and can be exposed to direct sun & heat.

BACKSTAGE ACCESS

20. Directors and Studio Chaperones must be present backstage during the event at all times.
21. Once backstage, Directors, Studio Chaperone or Dancers are not permitted to leave backstage facilities unless escorted by TP World Tours or Dreamworld staff member.
22. All Directors, Studio Chaperone and Dancer will have an official meet time and location to be escorted backstage – siblings, parents, grandparents and friend are not permitted to enter Dreamworld at this stage.
23. Dancers will arrive in performance hair and make up (show ready) in studio uniform and will change into costume once backstage. No costumes are permitted to be worn inside Dreamworld other than during the parade event.
24. Please refer to the Information Pack that will be provided to all Directors 90 days prior to parade date for further information.

COVID POLICY

25. Restrictions are subject to change at any stage prior to departure and whilst on tour. Each family will be required to follow the directions imposed should any changes occur and are liable for their own costs as a result of these changes due to COVID-19.
26. In the event of a COVID outbreak affecting the parade, the event will be rescheduled to an alternate date and all participants will be notified at that time. If your studio is unable to participate in the rescheduled parade, credit will be offered for the full amount paid to utilise towards a future parade event.
27. Many venues throughout QLD including Dreamworld and WhiteWater World are required to follow the Public Health and Social Measures linked to vaccination status implemented by Queensland Health from the 17th of December 2021. These measures currently outline that staff and patrons aged 16 years and older must be vaccinated in order to enter outdoor entertainment venues, including theme parks. As a result of these measures, guests aged 16 or over will be required to present proof of vaccination for entry to Dreamworld and WhiteWater World. Age limits are subject to change at any stage.
28. All Directors, Studio Chaperones, Dancers, Family and Friends will be required to check into the QLD Check in app and show Dreamworld staff prior to entry.
29. As of 14 April 2022, the QLD Government have updated the above policy. Queenslanders will no longer need to check-in or show vaccination status at venues & events. Please note restrictions are subject to change at any stage prior to the event.

PAYMENTS

30. All payments are due by the specified due dates, failure to make payment by the specified due dates will result in auto-cancellation.
31. Non-refundable DEPOSIT of \$50 per dancer based on parade only performer package is required at the time of booking to secure your parade booking.
32. Staycation Dance tour packages will have different deposit payment requirements please refer to your individual staycation quote.
33. Non-refundable FINAL balance payment is due 60 days prior to the event, failure to make payment by final balance due date will result in auto-cancellation.
34. Payments can be made via direct deposit and credit card - please refer to our website for full payment details.
35. Please note TP WORLD TOURS credit cards are processed through a third party and any merchant fees are processed through the third party. Merchant fees are non-refundable in the event of any cancellation/refunds required at any stage of your booking. Please refer to <https://travelpay.com.au/> for full terms & conditions.
